(Revenue \$) THE FUEL FUND OF MARYLAND SERVES AS A VITAL NON-GOVERNMENTAL COMPONENT OF THE SOCIAL SAFETY NET DELIVERING FLEXIBILITY THROUGH INDEPENDENCE, ACCOUNTABILITY THROUGH SOUND GOVERNANCE, AND QUALITY SERVICE DELIVERY THROUGH MORE THAN THREE DECADES OF EXPERIENCE. THE MOST IMMEDIATE IMPACT OF FUEL FUND ASSISTANCE IS THAT A FAMILY STRUGGLING WITH PAYING A UTILITY BILL WITH HOUSEHOLD INCOME AT OR BELOW 200% OF POVERTY WILL BE ABLE TO KEEP THEIR LIGHTS ON, AND HEATING AND COOLING SYSTEMS WORKING. THE BENEFIT TO A SINGLE FAMILY IS A BENEFIT TO THE COMMUNITY AT LARGE.
