BOARD MEMBERS ACKNOWLEDGE ANY CONFLICTS REGARDING TOPICS DISCUSSED AT BOARD MEETINGS AND EXCUSE THEMSELVES WHEN APPROPRIATE. THESE ACTIONS ARE NOTED IN THE BOARD MINUTES.
