

THE MOST IMMEDIATE IMPACT OF FUEL FUND ASSISTANCE IS FOR A FAMILY STRUGGLING TO AFFORD A UTILITY BILL WITH HOUSEHOLD INCOME AT OR BELOW 200-PERCENT OF POVERTY, THAT WILL BE ABLE TO KEEP THEIR LIGHTS ON, AND HEATING AND COOLING SYSTEMS WORKING.
